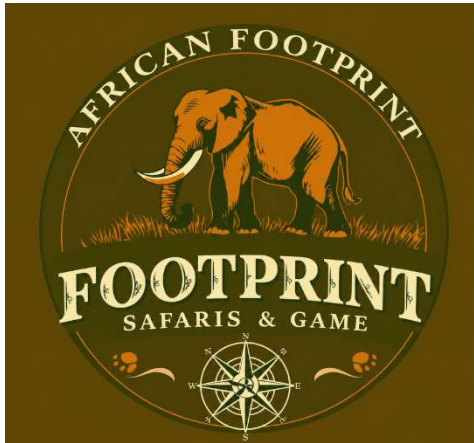

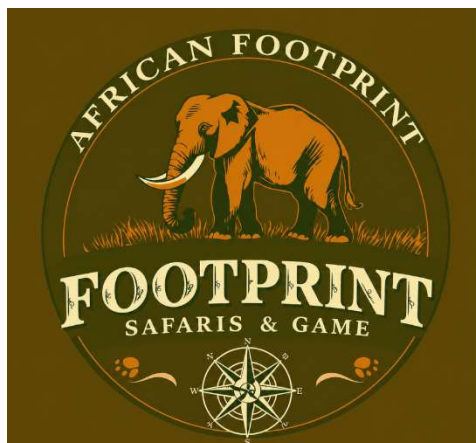

- Any costs associated with recovery of lost baggage

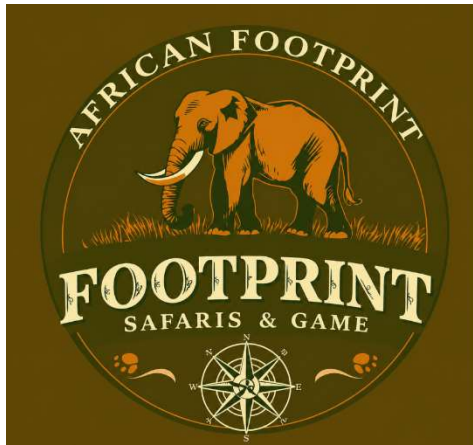
PACKAGE PRICE INCLUDES:

- Daily rates for the number of days specified, inclusive of:

INDEMNITY / WAIVER

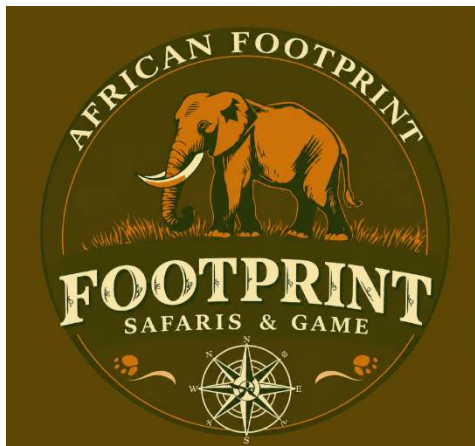
Acknowledgement of Risk and Release of Liability by Participants in respect of Safari Activities provided by African Footprint in Southern Africa.

The following waiver of all claims, release from all liability, assumption of all risks, agreement not to sue and other terms of agreement are entered into by me (the "Participant") with and for the benefit of African Footprint its owner(s), employees, volunteers, business operators, agents and site property owners or lessees (the "Host"). Without limiting the generality of the foregoing, Safari Activities includes but is not limited to : Trophy Hunting, Wing Shooting, Sight Seeing, Conveyance as Passenger in or on any Vehicle on Public or Private Roads or in the Bush or in the Veld, provided by the "Host" to the "participant".

I, the undersigned, (full names, passport number)

Having carefully read and understood this waiver before participating in Safari Activities, hereby declare:

1. I am aware that there are inherent dangers, hazards and risks ("Risks") associated with "Safari Activities" and injuries resulting from the "Risks" are a common occurrence. I am aware that the "Risks" of "Safari Activities" mean those dangerous conditions which are an integral part of "Safari Activities", including but not limited to:
 - (a) The propensity of any wild animal to behave in ways that may result in injury, harm or death to persons, other animals or objects;
 - (b) The unpredictability of a wild animal's reaction to such things as sounds, sudden movement, tremors, vibrations, unfamiliar objects, persons or other animals;
 - (c) The inherent danger that wild animals, reptiles, insects and plants poses for persons, other animals and objects;
 - (d) The potential for other participants and other persons to behave in a negligent manner that may contribute to injury to themselves or others;
 - (e) Conveyance in or on any vehicle (open or closes) on roads, in the bush or veld
2. I freely accept and fully assume all responsibility for all "Risks" and possibilities of any and all personal injury, death, damage to property or loss resulting from my participation in "Safari Activities".
3. I agree that although the "Host" has taken steps to reduce the "Risks" and increase the safety of the "Safari Activities" it is not possible for the "Host" to make the "Safari Activities" completely safe. I accept these "Risks" and agree to the terms of this waiver even if the "Host" is found to be negligent or in breach of any duty of care or any obligation to me in my participation in "Safari Activities".
4. In addition to consideration given to the "Host" for my participation in "Safari Activities", I and my heirs, next of kin, executors, administrators and assigns agree:



- (a) To waive all claims that I have or may have in the future against the "Host";
- (b) To release and forever discharge the "Host" from all liability for personal injury, death, damage to property, or loss resulting from my participation in "Safari Activities" due to any cause, including but not limited to negligence (failure to use such care as a reasonable prudent and careful person would use under similar circumstance) , breach of any duty imposed by law, breach of contract or mistake or error in judgment of the : "Host": and
- (c) To be liable for and to hold harmless and indemnity the "Host" from all actions, proceedings, claims, damages, costs, demands, including court fees and costs on an attorney and own client basis, and liabilities of whatsoever nature or kind arising out of or in any way connected with my participation in "Safari Activities".
5. I agree that this waiver and all terms contained herein are governed exclusively and in all respects by the laws of the Country, Province or Territory of Southern Africa in which the "Safari Activities" are provide by the "Host". I hereby irrevocably submit to the exclusive jurisdiction of the courts of the Country, Province or Territory of Southern Africa and I agree that no other court can exercise jurisdiction over the terms and claims referred to herein. Any litigation to enforce this waiver will be instituted in the Country, Province or Territory of Southern Africa, which the "Safari Activities" are provided by the "Host".
6. I confirm that I have had sufficient time to read and understand this waiver in its entirety. I understand that this agreement represents the entire agreement between myself and the "Host" and that it is binding on myself and my "Legal Representatives".
7. I confirm that I have reached the age of majority in the Country in which I am participating in Safari Activities.
8. Cancellation of the Hunt, 30 days Prior to the date agreed upon, for whatever reason, will not be accepted, and thus no refund will be paid to the client or agent.
9. Should any hunt be cancelled while the hunt is taking place, full payment of daily rates for the booked duration of the hunt will be liable by the client.
10. Should a hunt be cancelled while on promotion, or special package hunt, no refund will be paid to the client or agent.

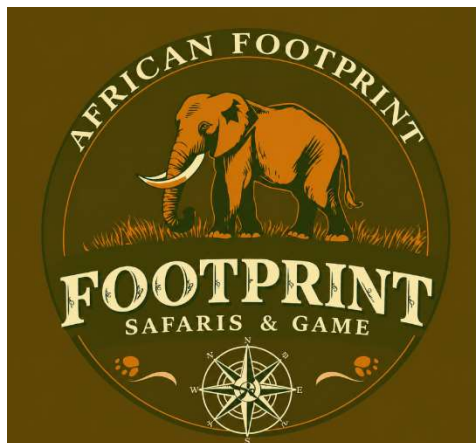

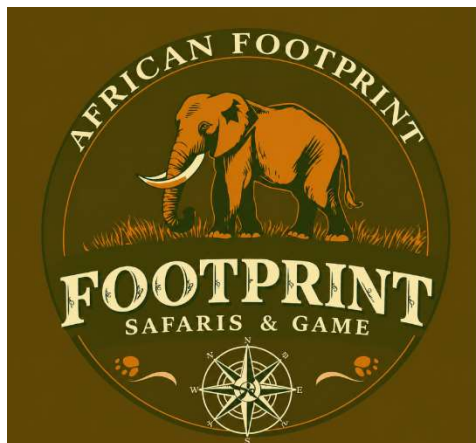

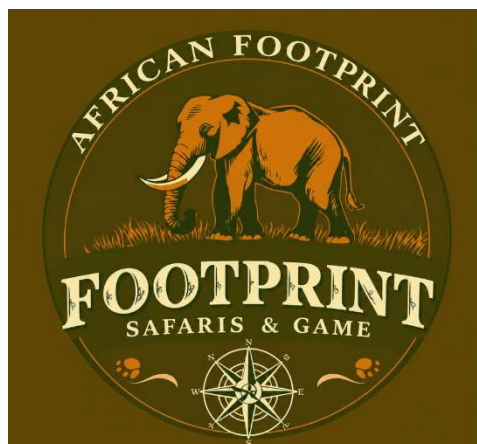

Gratuities

A frequently asked question:

“How much should I tip my PH, skinner, tracker and lodge staff?”

It's not an easy question to answer because tips are not obligatory and are at the discretion of the hunters. All staff are well informed of this fact and should accept anything given as a bonus to their salaries.

Here are some suggestions, merely a point of reference:

Tips can be given in US Dollar or in South African currency. On a typical basic plains game safari the average tip for the Professional hunter is between \$70 - \$100 per day. We recommend \$10 per animal that the skinner skins for you and if he was also your tracker and helper in the field each day, a couple \$'s extra, depending if he had to work hard to recover wounded animals for you.

On a standard safari we will stay at two different lodges so supporting staff may be tipped at your discretion. We advise you to give the tips to the helpers yourself, in a sealed envelope that we will provide.
